Families First Coronavirus Response Act



President Trump signed a second coronavirus emergency aid package into law Wednesday evening. This bill responds to the coronavirus outbreak by providing paid sick leave and free coronavirus testing, expanding food assistance and unemployment benefits, and requiring employers to provide additional protections for health care workers.

The bill also includes provisions that:

- establish a federal emergency paid leave benefits program to provide payments to employees taking unpaid leave due to the coronavirus outbreak
- expand unemployment benefits and provide grants to states for processing and paying claims
- require employers to provide paid sick leave to employees
- establish requirements for providing coronavirus diagnostic testing at no cost to consumers
- treat personal respiratory protective devices as covered countermeasures that are eligible for certain liability protections
- temporarily increase the Medicaid federal medical assistance percentage (FMAP).

Association has been working closely with the Alabama Department of Public Health and advocating for physicians throughout the state.

Yesterday, Alabama State Health Officer, Dr. Scott Harris, in consultation with the Medical Association implemented a Statewide Social Distancing Order. During the emergency, all elective medical procedures are ordered to be delayed. See the full order here.

We support ADPH's decision in banning elective procedures and imposing restrictions on visitation. These changes will impose new challenges for physicians; however, we want to provide

clarification on the order itself. **The order is not intended to force physicians to close their offices.** The definition of "elective procedure" within the order is intentionally broad enough to allow physicians to exercise judgement on what constitutes an elective procedure versus an immediate healthcare need. The informal guidance given as to what is, and what is not, elective is a reference to <u>CMS Adult Elective Surgery</u>. <u>Procedures and Recommendations</u>.

The Medical Association President, John S. Meigs, MD, FAAFP, says it best, "Our physicians are on the front lines and will continue to provide first contact, preventative and ongoing essential care during this medical crisis. We trust physicians to work at their discretion while maintaining proper social distancing techniques and other safety precautions suggested by Governor Kay Ivey and the Alabama Department of Public Health."

UPDATE: Daycare Prohibition Order Amended

The order given yesterday also closes all preschools and childcare centers, except for those operated exclusively for the benefit of law enforcement, hospitals, ESRD Treatment Centers, EMS and state and local governments. The childcare center must be employer-operated and located on the premises for the exception to apply.

The Medical Association requested an amendment to this order to include all healthcare workers, including physicians and their office staff. The order has been amended to reflect that change.
