PPE shortages have caused tremendous challenges for the healthcare system in Alabama and across the United States. Because these shortages posed a threat to Alabama physicians' health and safety, the Medical Association felt that it was critical to find opportunities for our members to purchase Personal Protective Equipment.

Three weeks ago, we began a partnership with ActionPPE to offer Alabama physicians the opportunity to purchase Personal Protective Equipment (PPE) including disposable masks, N95 masks and disposable gowns. Launched in South Carolina by the Charleston County Medical Society, ActionPPE is an effort to connect members with a vetted bulk PPE supplier. ActionPPE has also worked with medical associations in Arizona, Colorado, Georgia, Idaho, Illinois, Iowa, Louisiana, North Carolina, Ohio, Pennsylvania, South Carolina, Utah and West Virginia.

During the past few weeks we have received over 150 orders, totaling around \$90,000. Our staff has been working diligently to sort and organize the orders. This has been a team effort and we want to say a special thanks to the Home Depot in Prattville, Alabama. While purchasing supplies, Home Depot decided to donate the boxes we needed to fill all of the orders.

<u>Alabama Daily News</u> reports that a great deal is at stake in producing a full and complete full count of Alabama's entire population in the 2020 Census because Alabama could lose its seventh seat in the House of Representatives.

Census kickoff efforts in March and April got off to a slow start because of the coronavirus. Alabama had a 72% response rate to the census 10 years ago. State officials have said they want more than 72% this year to ensure billions in federal funding for dozens of state and community programs and to secure the state's seven congressional seats.
