Medical Association Emphasizes Importance of Physician Supervision to CMS



The Medical Association is taking a strong stand in support of physician supervision in response to a proposal from the Centers for Medicare and Medicaid Services (CMS) that could set a dangerous precedent in the removal of physician supervision requirements across all health care settings.


In a letter co-signed by the AMA and other medical associations from across the country, we voiced our opposition to a new proposal that would amend regulations allowing the use of non-physician practitioners (NPPs) to perform Inpatient Rehabilitation Facility services and documentation requirements that are currently required to be performed by rehabilitation physicians.

As we communicated in our letter to CMS Administrator Verma, we believe that relying on physician leadership, including in the IRF setting, is the most effective approach to maximizing the unique and complementary skill sets of all health care professionals on the team to help patients achieve their care goals.

We will continue to provide you updates on our progress with CMS and their proposal.

Fellow Alabama physicians,

I would like to encourage you to complete a survey that the American Medical Association (AMA) and the Medical Association of the State of Alabama developed to support you for the duration of the COVID-19 pandemic.

The survey addresses some important issues, including how much time you have spent caring for COVID-19 patients, the availability of PPE, health care staff and patient safety and wellbeing, telehealth, billing and reimbursement, how the pandemic has affected your practice, your expectations for what will transpire over the next several months, the efficacy of the federal relief packages, and "re-opening" barriers.

We will use the results of this survey to advocate on your behalf with legislators, regulators, and other key stakeholders.
