Proposed 2021 Medicare Pay Schedule: 9 Things Doctors Should Know



The Medical Association is working with the AMA and many national specialty organizations to eliminate or waive the 11% reduction in the Medicare conversion factor proposed by CMS in their recent physician payment rule. See the story below from the AMA.

Significant positive changes are on the way for 2021 related to coding and payment for evaluation and management (E/M) physician office-visit services. Also looming, however, are several potential negative changes, such an offsetting across-the-board payment cut for all physicians and other

health professionals, as detailed in the proposed 2021 Medicare physician payment schedule issued by the Centers for Medicare & Medicaid Services (CMS).

While those two developments have garnered most of the attention, the 1,355-page document also contains a host of other details that signal how COVID-19, budget-neutrality requirements and a myriad of other factors will shape health care operations and economics next year.

Deadline Extended to Apply for COVID-19 Provider Relief Funds



Eligible physicians now have until Sept. 13 to apply for up to 2% of total annual revenues to help offset increased expenses and lost revenues resulting from the COVID-19 public health emergency. Physicians who primarily care for patients with Medicaid or CHIP coverage may be eligible. In response to Medical Association of the State of Alabama and AMA advocacy, the Department of Health and Human Services (HHS) fixed an eligibility problem that had previously excluded physicians who had received an automatic disbursement from the Provider Relief Fund earlier this year because they see a few Medicare beneficiaries, even if those physicians had returned the disbursement. Provider Relief Fund payments are grants, not loans, and do not need to be repaid. HHS extended the previous deadline, which was Aug. 28. While the additional time was appreciated, the Medical Association and the AMA are urging HHS to meaningfully extend the deadline and keep open the application portal so physicians have sufficient time to apply for this critical funding. Physicians are focused on continuing to care for their patients during this unprecedented public health emergency and need more time to determine eligibility and submit their applications.

Five Things to Consider When Selling Your Practice to a Private Equity Firm





Alabama Coronavirus Update: New Cases Tick Upwards as Experts Plead for Responsibility over Labor Day Weekend



The daily average of new coronavirus cases in Alabama trended upwards in the last week as health experts urged the public in the strongest terms possible to keep observing COVID-19 precautions over the Labor Day weekend.

The warnings about public behavior over Labor Day were made in particular by Dr. Jeanne Marrazzo, M.D., director of UAB's Division of Infectious Diseases, who briefed reporters by videoconference on Thursday afternoon.

In Alabama, 114 individuals were hospitalized with COVID-19 on average each day over the last week, roughly in line for where the state's hospitalizations have been since the third week of August.
