Presentation Recording: New Grant Program for Alabama Physicians with COVID-19 Expenses



In response to our advocacy and recommendations, Governor Kay Ivey allocated \$35 million from Alabama's federal coronavirus relief money to set up a grant program to help physicians and other health care and emergency response providers affected by the COVID-19 pandemic. On a first-comefirst-serve basis, the state of Alabama will offer cash grants in an amount up to \$15,000 (per practice) for Alabama health care providers that meet eligibility requirements.

State Finance Director, Kelly Butler, joined us for a call last night to highlight new opportunities for financial assistance through Governor Ivey's Alabama Health Care and Emergency Response Providers grant program. He began with a brief overview of the program and focused on some frequently asked questions such as eligibility requirements, the application timeline and process, eligible expenses, and much more.

Alabama COVID mask order extended to Nov. 8



Gov. Kay Ivey is extending the order requiring facial coverings in public places until Nov. 8.

Ivey and State Health Officer Dr. Scott Harris issued the mask order effective July 16 as the state saw increasing numbers of coronavirus cases. The order was extended twice, most recently on Aug. 27, and was set to expire Friday. It is now extended through Sunday, Nov. 8.

Trump tests positive for COVID-19, will begin 'quarantine and recovery process'



President Donald Trump said early Friday that he and First Lady Melania Trump have tested positive for the coronavirus, a stunning announcement that plunges the country deeper into uncertainty just a month before the presidential election.

Trump, who has spent much of the year downplaying the threat of a virus that has killed more than 205,000 Americans, said he and Mrs. Trump were quarantining. The White House physician said the president is expected to continue carrying out his duties "without disruption" while recovering.

Medical Association Advocates for the Future of Telehealth



Last month our Third-Party Task Force met with Darrel Weaver, MD, the Vice President of Healthcare Network Services with Blue Cross and Blue Shield of Alabama. This meeting was an opportunity for us to reiterate our hopes that future Blue Cross telehealth coverage will be on par with in-person services, will be available to all PMD physicians whose services can reasonably be provided via telehealth, and will include audio telehealth visits for those patients who have limited broadband services.

HHS Announces a New Round of Provider Relief Funds

HHS announced today that it will be disbursing another \$20 billion in CARES Act Provider Relief Funds. Under this Phase 3 General Distribution allocation, physicians that have already received Provider Relief Fund payments may apply for additional funding that considers financial losses and changes in operating expenses caused by the coronavirus.

Recognizing the negative impact of the COVID-19 pandemic has increased anxiety and depression in the country and behavioral health providers have continued to provide care through telehealth and other means, HHS is also announcing that the nation's behavioral health care providers, including psychiatrists, are now eligible for funding.

Previously ineligible physicians, such as those who began practicing in 2020, will also be eligible to apply. Physicians will have from October 5, 2020 through November 6, 2020 to apply for Phase 3 General Distribution funding.
