Trump leaves hospital, returns to White House



President Donald Trump returned to the White House after leaving the military hospital where he was receiving care for COVID-19. Despite his illness, he declared that the nation should not fear the virus that has killed more than 210,000 Americans — and then he entered the White House without a protective mask.

Trump's message alarmed infectious disease experts and suggested the president's own illness had not caused him to rethink his attitude toward the disease, which has also infected the first lady and several White House aides, including new cases revealed yesterday.

CDC says coronavirus can be spread through airborne transmission



Two weeks after the Centers for Disease Control and Prevention took down a statement about airborne transmission of the coronavirus, the agency on Monday replaced it with language citing new evidence that the virus can spread beyond six feet indoors.

"These transmissions occurred within enclosed spaces that had inadequate ventilation," the new guidance said. "Sometimes the infected person was breathing heavily, for example while singing or exercising."

Association Advocacy Spurs New Grant Program for Medical Practices



Due in part to the COVID-19 Impact Survey and the advocacy efforts of our Association, Governor Ivey has awarded \$35 million in Coronavirus Aid, Relief and Economic Security Act (CARES Act) funds to establish the Alabama Health Care and Emergency Response Providers grant program. The grants will support providers who have been financially impacted by the COVID-19 pandemic.

On a first-come-first-serve basis, the state of Alabama will offer cash grants in an amount up to \$15,000 for Alabama health care and emergency response providers that meet eligibility requirements. The application period for the Alabama Health Care and Emergency Response Provider grant program opened yesterday and will continue until **noon on October 16, 2020.**

Medical Association Advocates for the Future of Telehealth



Last month our Third-Party Task Force met with Darrel Weaver, MD, the Vice President of Healthcare Network Services with Blue Cross and Blue Shield of Alabama. This meeting was an opportunity for us to reiterate our hopes that future Blue Cross telehealth coverage will be on par with in-person services, will be available to all PMD physicians whose services can reasonably be provided via telehealth, and will include audio telehealth visits for those patients who have limited broadband services.

HHS Announces a New Round of Provider Relief Funds

HHS announced today that it will be disbursing another \$20 billion in CARES Act Provider Relief Funds. Under this Phase 3 General Distribution allocation, physicians that have already received Provider Relief Fund payments may apply for additional funding that considers financial losses and changes in operating expenses caused by the coronavirus.

Recognizing the negative impact of the COVID-19 pandemic has increased anxiety and depression in the country and behavioral health providers have continued to provide care through telehealth and other means, HHS is also announcing that the nation's behavioral health care providers, including psychiatrists, are now eligible for funding.

Previously ineligible physicians, such as those who began practicing in 2020, will also be eligible to apply. Physicians will have from October 5, 2020 through November 6, 2020 to apply for Phase 3 General Distribution funding.
